4.1. Description of first aid measures

First-aid measures general : If you feel unwell, seek medical advice.

4.2. Most important symptoms and effects, both acute and delayed

5.3. Advice for firefighters

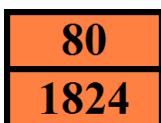
